7.3 Indicative Module Content, Organisation and Structure

This module will provide the learner with knowledge of the social and religious background of the Johannine corpus of writing. Learners will gain an appreciation of the literary composition of the fourth gospel and the presentation of the figure of Jesus in the fourth gospel including his self-presentation (*ego-eimi* sayings). Moreover, learners will become familiar with the personal encounters between Jesus and various individuals throughout the gospel, and the author's dramatic presentation of the Passion, death and Resurrection of Jesus. Learners will also develop a knowledge of the Johannine letters, their purpose and concerns and become familiar with the origins of apocalyptic writing and of the language, symbolism and message of the Book of Revelation and its enduring influence in history and literature.

Below is an indicative structure of the module content:

- The Johannine Community; introduction to the Johannine writings; questions of authorship, origin, date, language and style, imagery, literary genre; the gospel of John and the synoptic gospels
- The fourth gospel: Structure, sources, plot, theology,
- Close reading of individual texts: prologue, encounters between Jesus and various individuals; the interpretation of these texts and their impact on the reader.
- Examine portraits of Jesus, John the Baptist, Mary, Mary of Magdala, the apostles, Pilate.
- Letters of John and their contribution to the Johannine corpus.
- Revelation: apocalyptic, language and style, symbolism, purpose, enduring influence
