## IMMIGRATION REQUIREMENTS

**Medical Insurance:** All Non-EU learners are required to have private medical insurance when coming to and residing in Ireland for the purpose of study. The private medical insurance should provide cover for accident and/or disease and should cover the student for any period of hospitalisation. It is the responsibility of the learner to purchase private medical insurance.

**Proof of Sufficient Funds:** All Non-EU learners must show Irish Immigration that they have enough money to pay for their programme fees and all other living expenses while they live in Ireland. If you are from a non-visa required country to travel to Ireland, you must demonstrate proof of sufficient funds in the amount of €4,500 per year of studies. If you are from a visa-required country to travel to Ireland, you must demonstrate proof of sufficient funds in the amount of €10,000 per year of studies.

**Irish Immigration Registration Fee:** €300 (paid by bank / credit card only).

## REFUND POLICY

Programme fees are non-refundable once you have commenced your programme of study (i.e. officially registered with Carlow College, St. Patrick's); upon completion of your registration, you will receive a Letter of Registration from the International Office that will be required for Irish Immigration.

There are some exceptional circumstances where programme fees will be refunded in full:

- visa application has been refused, or you have been refused entry into Ireland, by Irish Immigration; and / or
- the programme does not run owing to low intake.

Where a visa application has been refused, the following documents are required to request a refund: a visa refusal letter is required (including appeal letter, if relevant); payment confirmation receipt(s) from the originating bank account and Carlow College, St. Patrick's payment receipt from Accounts.
