## Module aims and objectives

This module aims to explore the way that public policy shapes our lives and the different forms that politics takes. It addresses a variety of ways of thinking about politics and provides some of the key concepts and analytical frameworks used in analysing politics. This includes examining the practices involved in organizing public life, regulating who gets involved in decision-making and on what terms, and shaping how much influence they get to have over those decisions, whether at local, national or transnational level.

A distinctive feature of this module is its applied nature. As part of developing learner's skills in undertaking political and policy research, this module also focuses on building critical media literacy skills that facilitate learners' active engagement in current affairs. The module provides the opportunity to develop learner capacity for rigorous oral and written argument. Class discussion and the research assignment aim to foster a critical approach that will encourage learners to reevaluate commonly accepted ideas, to consider alternative explanations for important social and political developments, and to support conclusions with carefully deployed evidence. Learners will have an opportunity to carry out research into political life, developing analytical and debating skills.

The methodological nature of the Introduction to Contemporary Politics module provides learners with analytical and research skills in preparation for the Action Project in the module *Citizenship, Identity and Belonging*. Following from the *Introduction to Politics* module in semester 1, learners are introduced to the theory and logic of research and specific methodological approaches and to the range of research methods generally employed in political and social science research. Attention will be paid to research design, data collection, elementary data analysis, and writing skills. This is relevant to MIPLOS 3, 4, 5.

# Minimum intended module learning outcomes

On successful completion of this module, learners should be able to:

- 1. Understand policymaking processes, and the relationship between civil society and the development of public policy (MIPLO, 1, 2, 4)
- 2. Display strong critical media literacy and critically evaluate the impact of digital culture and new technologies on how politics is mediated and understood (MIPLO, 1, 2, 4, 5, 8)
- 3. Present a rigorous oral and written argument and demonstrate strong analytical and presentation skills (MIPLO, 1, 3, 4)
- 4. Demonstrate practical skills and competencies in quantitative and qualitative research methods in political and social research, including the analysis and interpretation of data and an understanding of the strengths, weaknesses, and contextual suitability of different methods of inquiry (MIPLO 1, 2, 4, 5, 7)

# Rationale for inclusion of the module in the programme and its contribution to the overall proposed Programme Learning Outcomes

This module introduces learners to contemporary politics and public policy and develops learners' skills in researching and analysing current affairs. It has three components: Developing student

understanding of key in contemporary politics; Developing student literacy and numeracy skills through engaging in political and policy research; Equipping students with skills to identify, analyse and interpret trends. This module informs each of the modules and particularly meets (MIPLOS 1, 2, 3, 4, 5). This builds on and compliments the development critical media literacy skills in *Media Studies and Digital Skills* module that facilitates learner's active engagement in current affairs in a cross-disciplinary manner and develops the capacity of the learner to think critically and analytically.

There is a significant focus in this module on the development of practical skills. The combination of practical skills with key concepts and theories provides a strong basis for the transfer of knowledge, skills and competencies to other modules, and presents an opportunity for integrated assessment strategies that encourage learner engagement and highlight the connection between theory and practice and will foster a more in-depth understanding of the complexity of the relationship between political institutions and civil society.

## Module teaching, learning and assessment strategy

Lectures, discussion forums, case studies and group exercises. Learners will, in small groups, break down the material in tutorials for greater examination of the issues. Prescribed readings will be used to encourage engagement by learners and will provide a basis for formative assessment or assessment for learning (Carlow College Teaching and Learning Strategy).

#### Module summative assessment strategy

This module will be assessed by three assignments:

### 100% Continuous Assessment

- 10% In class activities and debate
- 30% Online Quizzes (Data based questions on public policy and the policymaking processes; case studies)
- 60% Research Assignment: Learners will be asked to choose three sources of information about a contemporary news topic from different political orientations and evaluate the sources with reference to content, style, reliability of the information they contain (3000 words). A shortened version of the Research Assignment will be included as part of the final E-Portfolio in the *Pedagogy* module.
