Module aims and objectives

This module introduces the study of politics and is intended as a practical guide to some of the main concepts and vocabulary of political science. The module provides an introductory guide to important themes and issues related to the study of politics, such as the state, regime types, and political change and behaviour. It also introduces learners to some of the study skills that they need to complete assignments and assessments in the area of politics. This module is relevant to MIPLOs 1, 2, 3, 4. This module will introduce learners to political and social science research methods. It will provide learners with a foundational knowledge of the theoretical dimensions of conducting research in the field of political and social sciences. A variety of qualitative and quantitative research methods, data sources and methods of data analysis are explored.

Minimum intended module learning outcomes

On successful completion of this module, learners should be able to:

1. Identify and explain some of the core concepts used in political analysis. (MIPLO 1)
2. Contrast different political systems and forms of political power. (MIPLO 1, 2)
3. Demonstrate an appreciation of arguments about politics and the merits of different political systems. (MIPLO 1, 2)
4. Distinguish between different political institutions and electoral systems and demonstrate an understanding of the structure and functions they perform at Irish and European level. (MIPLO 1, 2, 4)
5. Demonstrate practical skills and competencies in reviewing texts of political analysis (MIPLO 3, 4)
6. Have an informed understanding of quantitative and qualitative paradigms, and the link between theory and practice in social research. (MIPLO 1, 2, 4)

Rationale for inclusion of the module in the programme and its contribution to the overall proposed Programme Learning Outcomes

There is a significant focus in this module on the development of practical skills. The combination of practical skills with key concepts and theories provides a strong basis for the transfer of knowledge, skills, and competencies to other modules, and presents an opportunity for integrated assessment strategies that encourage learner engagement and highlight the connection between theory and practice and will foster a more in-depth understanding of the complexity of the relationship between political institutions and civil society. The Research Assignment will be included as part of the final E-Portfolio in the Pedagogy module.

The module is relevant to all programme modules and helps learners to develop a deeper understanding of the individual module content.

Module teaching, learning and assessment strategy

The module is focused on the development of learner capacity to acquire self-awareness, to engage in critical reflection and to demonstrate a commitment to inclusion and ethical.
