Research is useful in determining the needs of an individual, group or community, and also contributes greatly to overall best-practice.
Module Aims and Objectives	This module will give learners an understanding of the methodological approaches utilised in social research, and make them aware of the role of research in informing both theory and practice. Learners should develop the skills and knowledge necessary to undertake a research project. They should also be capable of reading and interpreting research reports. Learners will be encouraged to examine sociological explanations for and evidence of poverty, inequality and discrimination.
Minimum Module Learning Outcomes	 Understand and apply the philosophical bases and characteristics of different methodological approaches in research (MIPLO 6). Appraise the available literature in order to justify a research question relating to their practice experience (MIPLO 2, 3, 6). Be capable of conforming to standards when conducting high quality, ethically sound research in professional practice (MIPLO 4, 6).

Module Content, Organisation and Structure	This module builds on the research methods content of Stage 1 Introduction to Sociology. Over the semester, it will cover the principles and practice of research methodologies, including the ethical and political issues involved. Furthermore, literature searching and reviewing, developing a research question, writing a proposal and interpreting the results of data analysis will be covered and applied. Small group peer learning workshops will promote in learners the ability to apply research skills in a safe environment. Conducting a Literature Review will enable and inform learners in understanding real-world research. Learners will be encouraged to examine sociological explanations for, and evidence of, poverty, inequality and discrimination.
